RE: 4-H RABBIT SHOW (**ENTRY FORMS DUE: OCTOBER 10th**)

Dear Rabbit Exhibitor and Parent(s),

The Annual Lafayette Parish 4-H Rabbit Show will be held on Saturday, November 8th as part of 4-H Fall Fest. In order to show at the Parish 4-H Rabbit Show, you must follow the instructions listed below. All rabbits entered in the show must be in possession and care of the exhibitor by **October 9th**.

- 1) Rules for the 4-H Parish Rabbit Show are contained as part of the 4-H Fall Fest Rules. You will find a copy of the rules on the back side of this page. Please read carefully.
- 2) All rabbits must be entered in advance. Parish show entry forms are enclosed. One form must be completed for each rabbit. If you need additional forms, please make copies.
- 3) When completing the entry form, be as accurate as possible. Indicate the breed of rabbit on the enclosed 4-H Fall Fest rules. If you're unsure of your breed, call the 4-H Office.
- 4) All 4-H parish rabbit show entry forms are due in the 4-H office no later than **October 10th**.

- 5) All rabbits entered in the show will be required to have an ear tattoo or ear mark in the left ear as a method of identification. An ear mark can be done with a permanent marker.

Fall Fest Rabbit Show Rules

Rabbit Show

1. Will begin at 9:00 AM. Contestants should arrive by 8:30 AM.
2. Exhibitors should already have enrolled in the Rabbit Project and received a rabbit entry form to enter their rabbit(s) in the show. Rabbits must be pre-registered (See Rule 7).
3. Exhibitors must have had their rabbits by October 9th.
4. Rabbits do not have to be registered, but each rabbit brought to the show must have an ear tattoo or ear mark (permanent marker) for identification (left ear) and current health papers.
5. Rabbits will be classed according to breed, sex, and age (under and over 6 months) with exhibitors allowed to show no more than one rabbit per class.
6. Breed classes will be determined based on the number of entries. Any pure breed with 3 or more rabbits will make its own class. If you are unsure about the breed of your rabbit, contact the 4-H office.
7. Completed forms must be turned into the 4-H office by October 10th. They may be found on our parish office website at <https://www.lsuagcenter.com/>
8. Rabbits showing any symptoms of disease may be excluded from exhibition and asked to be removed from show area. **CAPTIVE WILD RABBITS ARE NOT ALLOWED.**
9. All rabbits not properly entered as explained above will be assigned into a "late entry" class and will not have a chance to compete for championship honors.
10. 4-H members should be at Fall Fest to show their own rabbits. Another 4-H'er can place the rabbit on the judging table if that exhibitor is participating in another 4-H contest.
