UNION PARISH 4-H SHOOTING SPORTS
RULES OF THE RANGE

1. Proper use of the firearm. This includes being with an adult, being safe, proper safety gear, correct ammunition, positive attitude, and use of a safe and properly cleaned firearm.
2. No running on the range.
3. No use of any drug that prevents the shooter from being safe, this includes use of drugs prior to going to the range. No use of illegal drugs is tolerated.
4. No loud or rude behavior.
5. No manners that is unbecoming of a lady or gentleman.
6. No vulgar language.
7. No unsafe acts with a firearm.
8. No lying, cheating, or stealing.
9. Safety gear will be worn while on the range by all persons all the time.
10. Only guns that have been approved by an instructor will be allowed on the range.
11. Use of alcohol, either prior to or on the range will not be allowed on the range.
12. Clowning or playing around, pranks or any acts deemed unsafe by the range officer or instructor will not be allowed.
13. Inability to follow instructions or procedures will not be allowed.
14. Please sign range papers or give the proper information at the range every time you shoot.
15. Never leave a firearm or ammunition unattended.
16. Intentionally breaking any of these or other range rules are ground for dismissal from the range without prior warning.

Shooting Sports Participants

Mission Statement:

The 4-H Shooting Sports program strives to assist young people in personal development, in establishing a personal environmental ethic and in exploring life-long vocational and avocational activities through the use of experiential learning and positive interactions with youth and adult role models.

All adult volunteers and youth engaged in the use of firearms and/or archery equipment will be advised of the basic range safety rules before shooting starts by the Level I or Level II instructors in charge.

The Louisiana 4-H Shooting Sports programs will use 4-H club owned equipment, equipment loaned by industry or a support organization, and participants equipment that has been approved and inspected that day by the Level I or Level II instructor responsible for the training session.

No re-loaded (hand-loaded) ammunition will be used in the Louisiana 4-H Shooting Sports Program, and the reloading of ammunition will not be taught.

Competition will be developed as the need and interest grows.

Participants will be recognized for skill levels attained in each discipline.

A dress code will be enforced on the shooting range. No halter tops, tube tops, cut off blue jeans, jeans with holes, obscene T-shirts, baggy and loose clothing **will not** be accepted and permitted on the shooting range.

No horse playing and obscene language will be allowed.

I will respect the participants, volunteers and property associated with the 4-H Shooting sports program.

I will conduct myself in a professional and ethical manner.
